

NOTICE OF AWARD

- 1. The Government of the Democratic Socialist Republic of Sri Lanka has received a financing from the Asian Development Bank (ADB) towards the cost of the Integrated Road Investment Program and intends to apply part of the proceeds of this financing to payments under the Procurement of Road Management Contract (RMC) for Rehabilitation and Improvement, Periodic Maintenance and Routine Maintenance Works of 51.7 km of National Roads in Galle District.
- 2. The Road Development Authority ("the Employer") invited sealed bids from eligible bidders under the International Competitive Bidding in accordance with ADB's Single-Stage: Two-Envelope bidding procedure. Bids were received at the deadline for submission on 15 November 2018 at 14.00 hrs for the above contract package.
- 3. The bidders who have submitted substantially evaluated responsive technical bids along with bid prices were read out at the price bid opening held on 25 January 2019 and the evaluated bid prices are as follows.
