The Government of the Democratic Socialist Republic of Sri Lanka has received financing from the Asian Development Bank (ADB) towards the cost of the Integrated Road Investment Program Tranche 1 and intends to apply part of the proceeds of this loan to payments under the Procurement of Road Management Contract (RMC) for Rehabilitation and Improvement, Periodic Maintenance and Routine Maintenance Works of 51.7 km of National Roads in Galle District.
- 2. The Road Development Authority established under the Ministry of Highways and Road Development intends to execute a Road Management Contract (RMC) as a method for achieving sustainable and cost effective road asset management whilst at the same time meeting the needs of road users. The contract t includes a road length of about 51.7 km in Galle district, comprising of the following sections of National Roads and the contract period is 66 months

- 3. International Competitive Bidding (ICB) will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure (1S2E) and is open to all bidders from eligible countries as described in the bidding document.
- 4. Eligible bidders must meet the following criteria;
 - (i) Pending Litigation shall not represent more than 50% of the bidder's net worth.
 - (ii) The bidders' net worth within last 3 years shall be positive.
 - (iii) Average Annual Construction Turnover (AACT) within last 3 years US\$ 45 million
 - (iv) Availability of Financial resources for the Contract US\$ 2.5 million,
 - (v) Participation in at least one road construction and / or rehabilitation contract that has been successfully or substantially completed within the last 5 years, where the value of the Bidder's participation exceeds US\$ 24 million
 - (vi) Construction experience in following key activities within 12 months of last 5 years
 - Asphalt concrete paving works: 25,000 Metric Ton
 - Aggregate Base Course Work: 30.000 Cubic Meter
 - Concrete Works: 15,000 Cubic Meter

Bidders are advised to note the qualification criteria and evaluation procedure specified in Section I – Instructions to Bidders (ITB) and in Section III – Evaluation and Qualification Criteria of the Bidding Documents, to qualify for award of the contracts.

- 6. Bidding documents requested by mail will be dispatched by registered speed post / courier on payment of an extra amount of Sri Lanka Rupees 25,000.00 (US\$ 160) for overseas shipping. The Road Development Authority will not be held responsible for the postal / courier delay, if any, in the delivery of the documents or non-receipt of the same. Other details can be seen in the bidding documents.
- **7.** Pre-bid meetings and site visit will be held as follows:
