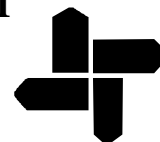

The Democratic Socialist Republic of Sri Lanka (GOSL) has received a loan from KUWAIT FUND FOR ARAB ECONOMIC DEVELOPMENT (KFAED) Loan No.886 in Kuwaiti Dinars toward the cost of project for Reconstruction of 25 Bridges carried out by the **Special Projects Management Unit of the Road Development Authority, Sri Lanka**.
