NOTICE OF AWARD

The Government of the Democratic Socialist Republic of Sri Lanka (GOSL) has received a loan from the Asian Development Bank (ADB) which will be utilized for Civil Works Contract for SASEC Port Access Elevated Highway Project. The Road Development Authority, the implementing agency for the road sector intends to apply a portion of the proceeds of this loan toward the cost of above Consultancy Services to make eligible payments under the contract for which this Request of Proposal issued.

The Road Development Authority (RDA) invited Expression of Interest (EOI) from consulting firms in eligible source countries of ADB, and Twenty three (23) consulting firms responded by sending their EOIs. The Cabinet Appointed Consultant Procurement Committee (CACPC) evaluated all received Expressions of Interest and approved a shortlist of six (06) firms.

All six consulting firms in the approved shortlist were requested to submit their Technical and Financial Proposals in separate envelopes simultaneously and as follows.

According to the evaluation of Technical Proposals, only five firms obtained score above the minimum of 750 out of 1000 points and qualified for further evaluation by opening of their Financial Proposals.

The CACPC opened and evaluated the Financial Proposals submitted by the five (05) firms who were qualified in the evaluation of Technical Proposals. Final ranking of firms was done by the CACPC after the evaluation of Financial Proposals, based on the combined score which was computed from the scores obtained by the firms for the Technical Proposal and the Financial Proposal respectively. The contract for providing consulting services for Construction Supervision for SASEC Port Access Elevated Highway Project was awarded to the first ranked firm *M/s Sheladia Associates, Inc. of USA Joint Venture with Roughton International Ltd, United Kingdom and MG Consultants (Pvt) Ltd Sri Lanka* for a Contract Amount of *USD 4,494,617.50 (American Dollars four million four hundred ninety four thousand six hundred seventeen and cents fifty) and LKR 587,910,450.00 (Sri Lankan Rupees five hundred eighty seven million nine hundred ten thousand four hundred and fifty) excluding VAT.*
