8. As per the Public Contract Act no. 3 of 1987, the Agent and successful winners of the tender shall be registered in the Department of Registrar of Companies.
9. Bid shall be accompanied by a Bid- Security for an amount given in the above table. Bid- Security shall be valid up to **31/03/2021**
10. The interested bidders should obtain a **Pay Order of Rs. 37,800.00 (valid for 90 days) for non-refundable tender fee drawn in favour of the "Director General - Road Development Authority"** and submit with the bidding documents. The bidding documents without the Pay order will not be accepted.
