- Bid shall be accompanied by a Bid- Security for an amount given in the above table. Bid- Security shall be valid up to 31/03/2021
- 10. The interested bidders should obtain a Pay Order of Rs. 37,800.00 (valid for 90 days) for non-refundable tender fee drawn in favour of the "Director General -Road Development Authority" and submit with the bidding documents. The bidding documents without the Pay order will not be accepted.
