- 02. The work consists of Construction of Anchorage Block, Pylon, Abutment and Superstructure.
- 03. Bidding will be conducted through the National Competitive Bidding Procedure. Since the total cost estimate of this procurement is below Rs. 50Mn, regional preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No.04/2016(ii).
- 04. To be eligible for contract award, the successful bidder shall be currently registered with the Construction Industry Development Authority (CIDA) in C5 and C4 grade in bridges speciality.

A complete set of Bidding Documents in English language shall be purchased by interested bidders from Provincial Director (Sabaragamuwa), Road Development Authority, Ratnapura OR Director (Construction), RDA, 3rd Floor, "Maganeguma Mahamedura", Denzil Kobekaduwa Mawatha, Battaramulla from **20.01.2021** until 10.02.2021 during 09:00 hrs to 15:00 hrs upon the submission of a written application with a Pay Order of Rs. 3,780.00 (With VAT) (Validity Period - 90 days) for non- refundable fee drawn in favour of "Director General- Road development Authority").
