A complete set of Bidding Document in English language shall be purchased by interested bidders on submission of a written application with a Pay Order of Rs. 13,500.00 (with VAT) (valid for 90 Days) for non refundable tender fee drawn in favour of the "Director General Road Development Authority" to the Director (Construction), RDA, 3<sup>rd</sup> Floor, "Maganeguma Mahamedura", Denzil Kobbekaduwa Mawatha, Battaramulla from 02.02.2021 until 22.02.2021 during 09:00 hrs to 15:00 hrs.
