- 2. The work consists of reconstruction of bridge (single cell box), construction of approaches and incidental works.
- 3. Bidding will be conducted through the National Competitive Bidding Procedure. Since the Total Cost Estimate of this procurement is below Rs. 50Mn., regional preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016 (ii).
- 4. To be eligible for the contract award, the successful bidder shall be currently registered with the Construction Industry Development Authority (CIDA) in C5 or C6 grades in Bridges specialty.

A complete set of Bidding Document in English language shall be purchased by interested bidders on submission of a written application with a Pay Order of Rs. 3,780.00 (with VAT) (valid for 90 Days) for non - refundable tender fee drawn in favour of the "Director General -Road Development Authority" to the Director (Construction), RDA, 3rd Floor, "Maganeguma Mahamedura", Denzil Kobbekaduwa Mawatha, Battaramulla from 09.02.2021 until 01.03.2021 during 09:00 hrs to 15:00 hrs. As per the Public Contract Act no. 3 of 1987, the Agent and successful winners of the tender shall be registered in the Department of Registrar of Companies.
