A complete set of Bidding Documents in English language shall be purchased by interested bidders from Additional Provincial Director (East), Road Development Authority, Akkaraipatthu OR Director (Construction), RDA, 3rd Floor, "Maganeguma Mahamedura", Denzil Kobbekaduwa Mawatha, Battaramulla from 16.02.2021 until 09.03.2021 during 09:00 hrs to 15:00 hrs upon the submission of a written application with a Pay Order of Rs. 3780.00 (With VAT) (Validity Period 90 days) for non refundable fee drawn in favour of "Director General Road development Authority".
