

## CENTRAL EXPRESSWAY PROJECT SECTION3

[FROM POTHUHERA TO GALAGEDARA (FROM CH. 0+840 KM CH. 32+450 KM)]

DESIGN, BUILD, FINANCE, OPERATE, MAINTAIN AND TRANSFER OF SECTION FROM RAMBUKKANA (CH.12+890KM) TO GALAGEDARA (CH.32+450KM) OF CENTRAL EXPRESSWAY PROJECT-3

## **REQUEST FOR PROPOSALS (RFP)**

1. The Road Development Authority ("the Authority") now invites proposals on International Competitive Bidding procedure, from local and foreign investors for implementation of section from Rambukkana (Ch. 12+890 km) to Galagedara (Ch. 32+450 km) of Central Expressway Project – 3 on the basis of Design, Build, Finance, Operate, Maintain and Transfer (DBFOMT) method as details given below.

- 2. Bidding will be conducted in accordance with Single-stage-two-envelope bidding procedure with post qualification.
- 3. Eligible bidders must meet the qualification criteria as stated in the bidding document including followings which will be evaluated on a pass/fail basis:
  - (i) Pending Litigation shall not represent more than 50% of the bidder's net worth.
  - (ii) The bidder shall neither failed to perform any contract in last 3 years as stated in the RFP.
  - (iii) Involving operation & maintenance of at least two projects of 4 lane access controlled highway/Expressway/roadway having total length at least 10 km and with at least one (1) toll plaza for last two (2) years within last ten (10) years.

In addition, the following criteria will be assessed on scoring basis as stated in the RFP.

- (i) Experience in Design & Build contract of a 4 lane access controlled highway/ expressway/ roadway with at least one (1) toll plaza that has been completed and opened to operations for at least 24 months during the last 10(ten) years with Total Project Cost of at least USD 210,000,000.00.
- (ii) Having **Net Worth of at least USD \$100,000,000.00** at the end of each of the most recent **3** full financial years.
- 4. Bid shall be accompanied by a Bid-Security for an amount of USD 5 Million.

- 6. To purchase the bidding documents in English, bidders should;
  - (i) Write to address given under item 5 above requesting the bidding documents for "Design, Build, Finance, Operate, Maintain and Transfer of Section from Rambukkana to Galagedara of CEP-3".
  - (ii) Pay a non-refundable fee of **Sri Lankan Rupees (LKR) 250,000.00 (with VAT)** by cash or bank draft drawn in favour of the "*Project Director Central Expressway Project 3*" on Current Account No. 7040407 of Bank of Ceylon Battaramulla Branch

(A complete set of bidding document in electronic version could also be purchased via email on submission of written request along with a copy of valid cash deposit slip (contract number and name of the Contractor should be indicated on the cash deposit slip) of non-refundable fee as per the details under 6. (i) & (ii) above, via email address given under 5 above. The Original of valid cash deposit slip should be submitted with the bid. The bids without the original of valid cash deposit slip will be rejected)

The bidding documents will be issued during normal working days from **9.00 am** to **3.00 pm** at the address under 5 above, from **22/07/2021** till **05/09/2021**.

- 7. The bidders are advised to register in the Department of Registrar of Companies appropriately, as per the Public Contract Act no 03 of 1987.
- 8. Bidders shall be delivered the proposal to the address given below on or before the **dead line: 2:00 pm on 06/09/2021**
