2. In addition to above qualification Criteria, to be qualified for each contact package;
- Bidder shall demonstrate non-occurrence of any non-performance of a contract since 1st January 2018.
 - Bidder's Pending Litigation shall not represent more than 50% of the net worth.
 - Bidder's net worth in any one year within last three (3) years shall be positive.
 - Bidder shall possess experience in key activities as stated under Section 2.4.2 of Part 1 of respective Bidding Documents.
 - Bidder shall comply other requirements as stated in the Bidding Documents.
3. The duration of each Contract Package is **18 months**. The Works include the key items such as Site Clearing, Excavation, Embankment Construction & Soft ground Treatments, Sub Base construction, Construction of Structures (as applicable) including Drainage construction, Construction and improvements of Side Roads, Cross Roads & Temporary roads to the extent specified in the Contract required to construct main trace of Expressway up to top of the Sub Base level. (Base and Asphalt construction not included).

- (ii) Pay a non-refundable fee of **Sri Lankan Rupees (LKR) 200,000.00 (with VAT)** by cash or bank draft drawn in favour of the **"Project Director - Central Expressway Project - 3"** on Current Account No. **7040407 of Bank of Ceylon - Battaramulla Branch**

(A complete set of Bidding Documents in electronic version could also be purchased via email on submission of written request along with a copy of valid cash deposit slip (contract number and name of the Bidder should be indicated on the cash deposit slip) of non-refundable fee as per the details under 5. (i) & (ii) above, via email address given under 4 above. The Original of valid cash deposit slip should be submitted with the bid. The bids without the original of valid cash deposit slip will be rejected)

The bidding documents will be issued during normal working days from **09:00hrs to 15:00hrs** at the address under 3 above, from 01/09/2021 till 21/09/2021.

6. Bidders should deliver their bids on or before **14:00hrs on 22/09/2021 to The Chairman, Standing Cabinet Appointed Procurement Committee, Procurement Division, Ministry of Highways, 7th Floor, Maganeguma Mahamedura, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla** together with a Bid Security in the amount as specified in each Bidding Document.
7. Bids will be opened immediately after the deadline in the presence of bidders' representatives who choose to attend. (If electronic bid opening procedure is applicable, the procedure will be informed before the deadline for submission).
8. The bidder shall bear all costs associated with the preparation and submission of its Bids, and the Employer shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
