## **INVITATION FOR EXPRESSION OF INTEREST (EOI)**

# FOR SELECTION OF CONSULTANCY SERVICES FOR DESIGN REVIEW AND CONSTRUCTION SUPERVISION OF THE RUWANPURA EXPRESSWAY PROJECT PHASE - 1

#### FROM KAHATHUDUWA TO INGIRIYA

(FROM CH.0+000 km TO CH. 24+300 km)

1. The Government of Democratic Socialist Republic of Sri Lanka (GOSL) implements the Ruwanpura Expressway Project Phase - 1 from Kahathuduwa to Ingiriya (from Ch.0+000 km to Ch. 24+300 km). The Phase - 1 of the expressway consists of four Contract Packages as follows:

Package 1 - (0+000 to 7+300 km) - 7.3km Package 2 - (7+300 to 13+800 km) - 6.5km Package 3 - (13+800 to 20+300 km) - 6.5km Package 4 - (20+300 to 24+300 km) - 4.0km

The Project Executing Agency (PEA) intends to select a qualified **Local Consultancy Firm** to provide consultancy services for design review, construction supervision and management of the project for which this invitation for Expression of Interest (EOI) is issued.

The minimum requirement of experience shall be 10 years in providing consultancy services for construction supervision of expressways / highways as an individual or joint venture/consortium.

Financing will be arranged by the GOSL through Local Banks for the consultancy services. Construction of civil works are in progress as four separate Contracts.

- 2. The Expressway Construction Contracts will be administered under the FIDIC Condition of Contract for building and Engineering Works Design by the Employer (1999 First Edition Red Book)
  - Note: The detailed design responsibility has been transferred to the Contractor under Particular Conditions of Contract.
- 3. The PEA is the Ministry of Highways (MoH) and Project Implementing Agency (PIA) is the Road Development Authority (RDA).
- Main scope of the work is design review and construction supervision as described below, but not limited to the followings:
  - I. Review and approve the detailed design drawings and Contractor's other submissions,
  - II. Management of construction works as per the Contract Documents,
  - III. Certifying/recommending payments entitle to the contractor
  - IV. Manage Environmental and social requirements of the project
  - V. Preparation of reports related to the project,
  - VI. Verification/approval of Contractor's Survey Works, and
  - VII. Any other works related to the project.

From the effective date of the Consultancy Contract, the Contract duration of the consultancy services are expected for 45 months.

The Chairman, Cabinet Appointed Consultancy Procurement Committee (CACPC), invites eligible Local Consulting firms to show their interest in providing above consultancy services. The interested consultants are required to provide information indicating that, they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, financial capacity, etc.) as details indicated in the Forms in Article II and Article III. EOI documents (Article I, II and III) can be collected from the address given under the Item No.10 after publishing this advertisement.

- 5. The applicant may associate with other firms to enhance their qualifications but the number of partners in the Joint Venture must not exceed three (03). In case of Joint Venture, the shared ratio of each partner should be clearly indicated in the EOI.
- 6. The applicant shall bear all cost associated with the preparation and submission of this EOI and PEA shall in no case be responsible or liable for those costs regardless of the conduct or outcome of the process.
- 7. The applicant or their members that will cause conflict of interest with the civil work Contractor or PEA, will be disqualified.
- 8. The Consultant will be selected through Limited Competitive Bidding (LCB) among Local Consultancy Firms in accordance with the GOSL Procurement Guidelines in Quality and Cost Based Selection (QCBS) method.
- 9. The deadline for the submission of Expressions of Interest (EOI) is not later than 10.30 hrs. dated 29th October 2021 (during the working time) to the address below. An electronic EOI document submission will not be permitted. The EOI document should be submitted in signed hard copy form. The late submissions will not be accepted. All applicants will be advised of the results of their expression of interest. The applicants those who have been short listed will be invited to submit a Proposal for the Project's Consultancy Services (RFP).
