The Democratic Socialist Republic of Sri Lanka has received financing from the World Bank toward the cost of the Kandy Multimodal Transport Terminal Development Project, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include reviewing the designs prepared by the design-build contractor for the multimodal transport terminal facility and construction supervision and contract administration of the resulting civil works carried out by the design-build contractor. The project is expected to commence in mid-2022 and the construction is expected to be completed by the mid of 2025.

The main physical features of the terminal facility are:-

- 1. a three-level building for passenger loading and unloading bays, a roof -top commercial space,
- 2. a parking building,
- 3. a 200m long sky-walk to connect the roads, railway station and the Kandy Hospital,
- 4. pedestrian friendly public space,
- 5. diversion of a underground canal
- 6. lifts and escalators to for vertical transport of passengers within the terminal
- 7. IT based information panels for the commuters,

The Chairman, Cabinet Appointed Consultant Procurement Committee now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- i. Minimum 15 years of experience as consulting firm with core business of public transport engineering design and supervision,
- ii. Minimum two contract of architectural and structural design /design review of a building of comparable size (35,000 m<sup>2</sup>) and complexity in last 10 years.
- iii. Minimum 02 (two) comparable contracts in which the consultant has provided construction supervision and contract administration (preferably using design build contract forms) services within the last 10 years (cost of consultancy shall be more than USD 2.5 million)
- iv. Adequate core managerial capacity to undertake consultancy assignments.

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 revised November 2017 and August 2018 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest. In addition, please refer to the following specific information on conflict of interest related to this assignment: Please refer to paragraph 3.17 of the Procurement Regulations for IPF Borrowers, published by the World Bank.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection method set out in the Procurement Regulations.
