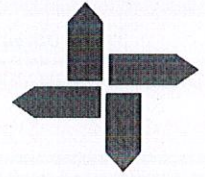

**SAUDI/OPEC FUNDED BADULLA CHENKALADI ROAD IMPROVEMENT PROJECT (BCRIP)
COMPONENT A (SFD) – AMPARA-UHANA-MAHAOYA ROAD (A 27)
(Section from 33+000km to 58+780km)**

The Democratic Socialist Republic of Sri Lanka has applied for a loan from Saudi Fund for Development (SFD) towards the cost of Improvements to Bibile to Chenkaladi of PBC Road (A005). It is intended that Part of this loan will be used for eligible payments under the contracts for rehabilitate and improve following roads, in Ampara-Uhana-Mahaoya (AUM) Road (A027).

1. The Road Development Authority (“the Employer”) now invites sealed bids from eligible bidders for following works.

3. The National Competitive Bidding (NCB) will be conducted in accordance with Single Stage Two Envelope Bidding Procedure and it is open to C1 and above Contractors registered CIDA in Sri Lanka.
4. Eligible bidders must meet the following general & specific criteria on a pass/fail basis.
 - (i) Pending Litigation shall not represent more than 50% of the bidder’s net worth
 - (ii) The bidders net worth of each year of last 7 years shall be positive
 - (iii) General experience in construction contracts within last 7 years
 - (iv) Average Annual Construction Turnover (AACT) within last 7 years and specific construction experience is given in the table below.
