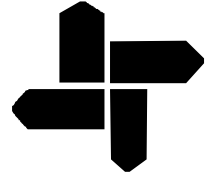

NOTICE OF AWARD

1. The Democratic Socialist Republic of Sri Lanka has applied for a loan from Saudi Fund for Development (SFD) towards the cost of Improvements to Bibile to Chenkaladi of PBC Road (A005). It is intended that Part of this loan will be used for eligible payments under the contracts for rehabilitate and improve following roads, in Ampara-Uhana-Mahaoya (AUM) Road (A027).
